WHAT WE DO. We help the elderly remain independently in their homes longer by offering professional and volunteer services. The staff also coordinates volunteer members to provide transportation to medical and other appointments, to help with shopping, household chores, delivering hot meals, and visiting shut-ins. Free medical equipment such as wheel chairs, walkers, and bath benches are available to all ShareCare members.

HELLO AGAIN from the ShareCare family of Leelanau County. Last month we gave you some basic facts about our organization. Today we focus on stirring your interest enough to call us or to ask one of our members about us.

SHARECARE'S GOAL is "to promote independence and well being for the elderly, enabling them to stay longer in their homes for as long as possible". We monitor their conditions, arrange transportation, and provide other basic services such as friendly visitors, handymen, and respite caregivers. We do all of this with a registered nurse, an office coordinator and over 150 terrific volunteers.

SPEAKING OF TERRIFIC VOLUNTEERS, Board member Jay Littell, who also acts as a volunteer driver-of-the-day and office helper, organized ShareCare's October 15<sup>th</sup> fall clean-up day to help get their yards ready for winter.

STAYING HOME LONGER has emotional and possibly financial advantages for the elderly. Folks love their own surroundings and privacy, and moving to a retirement home may be a challenge. Costs in the range of \$5000 per month are not unusual, so staying in one's home for, say, even another year is important. Someday the change may be necessary, but until then ShareCare can help.

HEALTH FUTURES. Would that we could predict our senior years. One ShareCare couple, in their vigorous sixties, learned that the husband was a cancer victim. Now, in spite of two years of the finest medical care, he is gone. During that difficult time, ShareCare was able to give comfort and help to him and his spouse. Now she is a dedicated ShareCare supporter.

PRIVATE SECTOR ORGANIZATION. There are several local agencies supporting seniors and we need them all. ShareCare as a non-governmental, non-profit, member-funded, volunteer-driven, small-staff organization, immune to the exigencies of public sector funding is unique. As a 501-C-3 organization, those who are inclined are able to give tax-exempt donations.

SENIOR CITIZENS, specifically, people over 65, number about 5000 in Leelanau County. The genius of ShareCare is that it creates an interactive, caring community that recognizes the needs of its elderly members as they progress through their retirement years. This is not an easy task, but many dedicated persons have worked to build and shape this terrific organization. Volunteers help everyday to continue this effort. So let us talk about some of these efforts.

VOLUNTEERS, about 150 of them, are organized into regions with the boundaries set by the four school districts of Leelanau County. Each area has at least two captains who arrange schedules for driving and other needs of our elderly members. The Driver-of-the-Day program, widely used by members, has volunteer drivers who stand by on their chosen day, and when a member calls the office for a ride, the volunteer is contacted with the request to drive. By the time the drive is complete, often a new friendship is made. Stories abound of the joys from these meetings, finding common interests in music, books or careers. This, in part, is what we mean by the genius of ShareCare.

CIRCLE OF CARE, started by dedicated volunteer Bev Almquist, is a new service ShareCare offers. It addresses those seniors who may live alone and go day after day without seeing anyone. Bev and her Circle arrange for daily phone calls to these members to make sure that all is well. How reassuring to them and their families that this cost-free service is available. Maybe it's not genius, but it sure is a good idea.

MERRY MARKETPLACE, an annual one-day market in the Old Art Building in Leland, uses volunteers in a different way. Knowing that fundraising is a necessity, ShareCare volunteers not only staff the booth, but also kindly provide the handcrafted items for sale at the Marketplace. Stop by the Old Art Building in Leland for some holiday shopping (candy, jewelry, clothing, woodcraft, seasonal items, etc.) on Saturday, December 3<sup>rd</sup>. Also, orders are being taken for Cermak's famous frozen, homemade apple pies. Call the office (386-0028) to reserve one for the holidays.

# SHARECARE NEWS COLUMN FOR DECEMBER 2005—2<sup>nd</sup> Draft

HOLIDAYS for the elderly can be lonely, but for certain, being in one's own home this time of year, is comforting. Family and friends can visit and help amid familiar surroundings. ShareCare's number one purpose is to enable the elderly to stay in their own homes as long as possible and to monitor their needs and to help with friendly volunteers or in finding qualified help.

MEDICARE PART D PRESCRIPTION has been in the news for the past months and many are confused about what to do. Volunteer Tom Evans arranged for two briefings this month by a government official, one in Omena and another in Empire. About fifteen people attended each briefing and were aided by ShareCare volunteers Dr. Jim Fenton and Barb Coye. Since many issues are involved, including whether or not a plan is needed, seniors should be cautious when choosing a plan. Also note that while the program starts January first, you have until May 15, 2006 to join without possible penalty.

VOLUNTEERS are the backbone of ShareCare. For those who are blessed with the need to lend a hand to their fellow man, we offer you the perfect opportunity to help others. ShareCare lets you get involved with a time commitment that best suits your needs, and as a bonus you get to know some dedicated people in one of the county's most respected organizations. Whether driving fellow members once a month, helping with minor home chores, or delivering a meal, you decide when and how to make a difference in serving the elderly, and our staff will make the arrangements.

WHAT DOES IT COST? ShareCare maintains a minimum staff of two: an office manager and an experienced registered nurse in the Leelanau Memorial (Tendercare) facilities in Northport. As a private sector 501C3 organization, funding comes from tax-deductible enrollment fees, annual dues and donations. Our fee schedule shows that the earlier you join the lower your costs. It's interesting to note that in most cases YOUR ENTIRE LIFETIME COST OF BELONGING TO SHARECARE WILL BE LESS THAN THE COST OF YOUR FIRST MONTH IN A RETIREMENT HOME. When you need us, perhaps after several years as a volunteer, we will be there to return the favor of helping you to stay in your home as long as you wish. By then we will be great friends.

#### BECAUSE SHARECARE JUST MAKES SENSE

Also available are free professional care planning, coordination and advocacy, monitoring by home visits, family consultations and free loaner medical equipment. Lastly, ShareCare maintains a list of qualified independent contractors for home repairs and maintenance, as well as carefully screened personal caregivers.

When all of these services are combined, it makes the approach to comprehensive assisted—living in your home as economical as possible. ShareCare has made sense to hundreds of families in Leelanau County for over 12 years, and its affordable membership and annual dues are fully tax deductible!

- More than 80 percent of the nation's elderly wish to remain in their homes as they confront advancing age.
- Community-based models for "aging in place" are the wave of the future, an alternative to nursing homes and assisted living centers.
- Elders want to remain at home even after transportation and household chores become difficult and dangerous.
- Many want to avoid dependence on adult children.

SHARECARE, A COMMUNITY-BASED private sector nonprofit organization, assesses the needs of its members and arranges, with professional help, for the regular and coordinated support that allows elders to remain in their homes. New members get a visit in their own home from our registered nurse, Anne Kelly, to record important health information and wishes should a health-related situation occur. Other services include:

- Professional care planning, coordination and advocacy
- Monitoring by home visits and family consultations
- Free loaner medical equipment
- Lists of qualified independent contractors for home repairs and maintenance
- Lists of carefully screened caregivers.

IN ADDITION, about 150 volunteers provide transportation to medical appointments, shopping, hair appointments and the like. The result of all this is economical and comprehensive assisted living in your own home. Our affordable membership and annual dues are fully tax deductible. Your lifetime cost for all of these services from ShareCare will be less than your first month in a typical retirement home.

HELLO AGAIN to all of you from the ShareCare family of Leelanau County, pioneers in community-based assistance to the elderly. We have been at it for over 12 years and we are the local experts in helping the elderly to stay in their homes as long as feasible. We have heard of similar organizations around the country, but not many have been at it as long as we have. A talented group of retirees founded this entity—doctors, nurses, ministers, and business people, probably your neighbors. Who better to understand the issues of growing old in Leelanau County?

AS A LOCAL RETIREE PUT IT, it is time to get on with the day's inactivity. With all joking aside, it seems that growing old is not for the meek of heart and presents many challenges—some good and some not so good: keeping busy, enjoying life, controlling pain, surgical needs, pharmacy costs, transportation, family crisis, and sometimes just getting the right food or sleep.

SHARECARE'S GOAL is to help the elderly with many of these needs in an economical and coordinated manner that allows them to stay in their own homes. Last month we told you that 80 percent of American elders want to "age in place", that is in their own homes. Our mission is to help them do that with these actions:

- Monitoring your health issues and needs by home visits and family consultations from our registered nurse, Anne Kelly
- Providing services by our 130+ volunteers, such as transportation to appointments, friendly visits, and light handy work
- Recommending screened caregivers
- Providing free medical equipment
- Suggesting qualified contractors for home repairs and maintenance

SOMETIMES RELOCATING IS PAINFUL. Do you remember how hard it was to move to a new home? Now in our older age the thought of moving is something we prefer to avoid, especially to the uncertainties of a group setting. Someday this may be required, but until then, ShareCare can help. There is a joining fee and annual dues, but the lifetime sum of these we expect to be less than your first month in a typical retirement home. So take our offer to postpone that next move for as long as possible. If you are inclined, join early for better rates and help us as a volunteer. You will find yourself among some very fine people!

"I am thrilled that ShareCare does such a great job of locating and screening caregivers", said George Basta, who has had the pleasure of the company of several ShareCaresanctioned caregivers. "Kerry and Nancy are tremendous and indispensable; they do everything for me!" Barb Wisniewski responded.

FINDING CAREGIVERS is probably one of the most important services that ShareCare can do for its members. Sometimes members only need help for a week or two when they return home from surgery or a stay in the hospital. Occasionally, members need caregivers for a parent or spouse while they are "up north" for the summer. Often, caregivers are hired for an extended period of time; either as the sole caretaker for a member who lives alone and needs daily help, or as a respite care person for a spouse who needs some free time.

"I JUST CALLED SHARECARE and told them what I needed and they found people to fill all the times that I required help", said Barb. George stated, "I'm amazed that my caregivers are so willing to do things, like laundry and cooking. They are just great people!" "Their extra help makes all the difference. My husband can now get out and play golf and play in his band," said Lauren Gilbreath.

SHARECARE'S STAFF, Anne Kelly, RN and Deb Wetherbee work with knowledgeable Board members to interview and screen potential caregivers. Then Anne and Deb place caregivers in members' homes and stay in touch, to make sure that everything remains harmonious. "I plan to keep my caregivers ad infinitum", said Barb. That is a pretty good testimonial!

Members may find themselves driving a fellow member to appointments or shopping; providing companionship to a shut in; helping with seasonal home clean-up or minor household projects; or providing occasional meals to a member who recently returned home from a stay in the hospital. Borrowing medical equipment and attending scheduled social and educational events are included in the membership fee and dues.

A MEMBERSHIP INCLUDES access to a list of paid services, such as caregivers, snow removal, plumbers, and electricians that ShareCare has evaluated for their reliability and reputation. Health care case management by our nursing staff is available to each member.

RECOMMENDING CAREGIVERS for its members is one of the most important roles that ShareCare may play in a member's life. A recent column discussed how members who are receiving care-giving support admire their caregivers. But those who do the giving say that their rewards are equally great.

"THIS HAS BEEN A BLESSING IN MY LIFE," stated Patti Anderson, a ShareCare caregiver. "You get back one hundred fold what you give, and I have met some of the nicest, kindest people, who have great stories to share."

MARY DIETRICH, A SHARECARE NURSE and caregiver said, "The people themselves are the reward that I get back." Mary pointed out that she has a knowledge base that families might not have, and added, "It is magic to see the changes in people as I am there. It may take some time, but they allow a stranger to provide comfort and help".
